Deposit and Payment: A deposit of 50% of the total cost is due at the time of booking, with the balance due prior to the rental.

Cancellation: The entire cost will be refunded if the rental is cancelled up to 48 hours in advance. Cancellations after that are subject to an administrative fee of \$50.

Terms of Use:

1. Use of brooms, grippers and sliders are included.
2. Head protection for all participants is strongly recommended and mandatory for all children 12 and under. Some adult helmets are available.
3. Only indoor footwear, free of sand and ice, is allowed on the ice (no winter boots).
4. Prior to the end of the rental period the User shall complete a general clean up of the areas used, including tables and chairs being returned to the condition they were provided; all dishes returned to kitchen scraped, rinsed, cleaned and ready for next rental or club use. All tables and counters wiped, kitchen floor swept and all garbage and recycling removed.
5. Smoking and vaping is not permitted.
6. No outside alcohol is permitted. Bar service is limited to the lounge area only.

7. The availability and the use of all Facilities is subject to all health and safety requirements (including any COVID-19 protocols) that are in effect generally at the time of the rental and also to any additional requirements as may be prescribed by the Club at such time.
8. The User shall ensure all activities are properly supervised and carried out in a safe manner and shall be in attendance during the entire rental period. The User shall be responsible for any damage to Club property.
9. The User assumes all risk of its use of the Facilities. The User does fully release and discharge, and agrees to indemnify and save harmless, the Club, its officers, directors, volunteers and representatives, from and against any and all claims, actions, costs, expenses and demands made by anyone in respect of death, injury, loss and damage to any person or property, no matter how caused, arising out of or in connection with or during the use of the Facilities by the User.
